RLST 249 Public Religious Discourses in Modern Islam Fall 2012

Course Description

This graduate seminar explores a variety of public discourses in modern Islam. In it we examine scholarly and popular discourses, such as the place of Muhammad, the Qur'an, religious pluralism, knowledge and public rituals, political Islam, democracy and human rights, gender, and capitalism, using various approaches, including scriptural/Qur'anic studies, legal studies, history, anthropology, political science and international relations.

Requirements and Grading

Attendance and Class Participation: 15 % of the total grade

Since this is a graduate seminar, students are required to demonstrate their engaged and engaging participation in which the professor serves as group leader. The professor presents some background information and some points for discussion, but the students are free to explore other points as well. Attendance in every class session is mandatory and participation is crucial. Students should be prepared to discuss the materials, ask questions actively, and speak critically on the issues at hand.

1 (one) presentation: 15 %

Each student will give one presentation critiquing the required reading of the week, asking thoughtful questions and leading the discussion. The student should provide a handout or an outline to be shared with the class and the professor electronically one day before the day of his/her presentation. Depending on the number of participants, there will usually be more than one student presenting in the same week.

Two Essays: 20 + 20 % = 40 %

Every student will write 2 (two) 4-5 page essays, one being developed from the presentation due within 1 (one) week, and the other being due on any week.

Final Term Paper and Presentation: 25 % + 5 % = 30 %

Every student will write one final paper of <u>10-12</u> pages. Students should combine the methodological and theoretical insights of the course with their own scholarly interests. By week 6, every student must have chosen a topic for the paper. Please do not wait too long to decide on a topic! The paper will be graded based on its thesis and evidence, coherency and consistency, clarity and presentation.

Students will present their final papers in the last two weeks of the term.
