Catalogue Description

4 Units, Lecture, 3 hours; individual study, 3 hours. Prerequisite(s): upper-division standing or consent of instructor. Examines key issues facing Islam in the modern world such as Islam's engagement with and reaction to nationalism, feminism, the status of sacred texts in the face of critical historical and philological studies, science, and technology.

Course Description

This course examines key issues facing Islam in the modern world, including the modern approaches to the Qur'an, the Prophet Tradition, and the images of Muhammad, theology, spirituality, law, politics, violence and peace, science and education, women and sexuality, the media, popular culture, American Islam, and interfaith relations. The course offers theoretical and methodological tools as well as rich data for understanding and explaining the complexity and diversity of Muslim beliefs, expressions, practices, and institutions in the modern world.

Learning Objectives and Outcomes

- Developing academic skills: a. thinking critically of Islam; b. reading and speaking critically; c. writing academic essays; d. working collaboratively on a creative project
- Understanding modern concepts and their uses for understanding Islam: modernity and tradition, religion, scripture, ritual, law, ethics, gender and sexuality, politics, and social movements.
- Understanding modern expressions of Islam in light of nationalism, globalization, feminism, religious pluralism, environmental crises and green movement, science and technology.

Course Requirements and Grading

- Class attendance and participation. Regular attendance, asking and responding to questions, and making informed comments, will be considered "active class participation". The discussions are intended to assist the students to thoughtfully analyze topics and issues pertaining to Islam in the modern world. It accounts for 15% of the total grade. Every absence beyond family and health emergency is a reduction of 2 points of the attendance grade.
- A short personal essay on "what I know, what I don't know about Islam and Muslims in the modern time, and what I want to learn from taking Topics in Modern Islam," 2 pages and double-spaced. A hard copy is due on Wednesday, April 3rd in the classroom. It accounts for 2.5 % of the total grade.
- 2 (two) academic essays (4-5 pages, including "Works Cited", double-spaced, first essay for 15%, the second for 15%) on two different topics related to Islam in the modern world. Each essay has to have at least two books or at least one book and one journal article. Several books and journal articles are highly recommended, although interview notes, participatory observation, and reliable websites as sources can be used as well. Books about various topics in modern Islam are available at Rivera Library and journal articles are accessible through JSTOR. Please consult with the instructor if you have any question concerning your essays. Graduate students will write 6-7 pages for each essay. The first essay is due in class on Friday, April 19th, 2019. The second essay is due in class on Friday, May 10th, 2019
- <u>A takehome exam</u>, answering five questions, 4-5 pages, double-spaced. It is due on Friday, May 31st, 2019. It accounts for 15 % of the final grade.
- A group project & an individual report of the group project. A group creative work of 3-4 students takes various forms, such as short story, calligraphy, poster, poem, drama, dance, music, song, video, game, brochure, creative power point presentation, or any piece of creative work after consultation with instructor. Group presentations will be held in the classroom on Wednesday, June 5th, and Friday, June 7th, 2017. Presentations take place for 5 minutes. Individual report is due at 12:00 p.m. June 12th, 2019. The project and its report accounts for 15 % of the total grade.
- A final academic essay accounts for 20 % of the final grade. The final paper is
 6-7 pages, typed and double-spaced, and a hard copy and a safe assignment will
 be due at 12:00 p.m. June 12th, 2019, in the instructor's office INTN 2018.
 Graduate students will write 9-10 pages.
- A short personal essay, about "what I have learned about Modern Islam and what I expect to do next", accounting for 2.5%. A hard copy will be due at 12:00 pm. June 12th, 2019, in the instructor's office INTN 2018: 2 pages, double-spaced, and typed.
